Submission Guidelines:

Entry must be submitted digitally (low resolution .jpg) for jurying to info@shorelinearts.org

Emailed entry should include "Small Works Exhibition" in Subject line & artist's name and contact information in message

Entry must consist of at least 2 works and no more than 5 works of art (works may have to be emailed separately)

Entry Deadline: December 10

Accepted artists contacted by: December 14

Accepted artists need to provide a typed artist statement on 8½" x 11" paper

Drop off date for original art: December 16, 6 – 8pm (Artwork should have artist's name & contact info on the back)

Works must be suitably framed, priced and ready to hang, sizes 8" x 10" or smaller

Exhibition Dates: December 18, 2009 through March 21, 2010

Opening Reception Date: Friday, December 18, 6 – 8pm

Show Closes: March 21, 2010

Pick Up Art: March 22, 2010, 6 – 8pm

In lieu of entry fee participating artists will be required to provide refreshments for the Opening Reception and/or volunteer to Gallery Sit.

A 20% commission will be retained by the presenting organizations on all sales.
